I hereby certify that every horse and rider is eligible as entered and agreed for myself and my representatives to be bound by the Constitution and Rules of Equine Canada and the River Valley Horse Show's Prize List. In consideration of being allowed to participate in this event, I hereby assume all risk and I hereby release and absolve Equine Canada, Gorsline Stables, Carol Gorsline, Whitemud Equine Centre, the City of Edmonton and their directors, officers, employees, volunteers, and representatives, for all responsibility, liability or claims of any nature and kind which I may have arising from my participation in this activity, including but not limited to bodily injury or death to myself or my horse(s) and damage to property arising from any cause whatsoever, including the negligence of one or more of the individuals and organizations referred to herein.

I hereby declare that in signing this document that I have read and fully understand and agree to the terms and conditions stated herein and that it is binding upon my executors, heirs and assigns. All persons mounted on a horse on the competition grounds are required to wear a properly fitted, ASTM or BSI approved helmet with safety harness correctly fastened. (see EC Article G102).
